## WHAT WE'RE ALL ABOUT

### Condensed Mission Statement

The MCCA is composed of programs that function in the community as alternatives to incarceration for adult offenders. Our mission is to establish ethical and professional standards of performance for programs and workers in the field; promote specialized education and training for community corrections workers; provide the means for communication, self criticism, public education and have a voice in the legislative process; and develop consistent and uniform evaluations.

Our concern is for a progressive and law abiding society. Our obligation is to provide for humane and effective programs for people who have come into conflict with the criminal justice system. To insure that we work towards these goals for the best interests of the community we have joined in this association.

### MCCA POSITION PAPER # 1

On June 1, 1976, the MCCA Board of Directors, on behalf of its membership, submitted a position paper to the National LEAA office in Washington, D.C.

The LEAA policy for the disbursement of LEEP funds has been interpreted of late to EXCLUDE from the eligibility list for educational loans and grants, those community corrections workers not employed directly by the State or County.

The MCCA position is that LEAA policy be interpreted to INCLUDE community corrections workers as eligible for LEEP funds as they are providing services to correctional clients within counties and the State of Minnesota, and are an integral part of the corrections system in Minnesota.

## LOOKING BACK. . . . .

The general membership meeting of the M.C.C.A. took place June 9, 1976, at the Catholic Youth Center, 2120 Park Avenue South, Minneapolis. All Association Members and guests were welcome.

The M.C.C.A. is involved in all aspects of community corrections. At this meeting areas of involvement were summarized by Chairperson Tom Christian.

Exploring and being aware of topical issues is also a concern of the M.C.C.A. "Client Rights and Community Corrections" was the topic of a panel discussion with the audience. Leading the discussion were Mel Golberg, LAMP, Mary, resident Eden House, Jim Krieger, Legal Rights Center, Murray Illies, resident Portland House, and Tom Rowe, Neighborhood Justice Center. The panel stated that generally lawyers will advise their clients to enter a program as an alternative to incarceration provided that a responsible approach to therapy is used. It was also stressed that cooperation is needed among program staff, lawyers and probation/parole officers to make treatment plans more effective.

Active participants spent the remainder of the afternoon in committees with focus on the specific areas of M.C.C.A. involvement.
